NSW Ports Business Update

4. Corporate Affairs update

B Eggleton presented the Corporate Affairs update, highlighting the following:

- The recipients of the 2023 Community Grants Program have been awarded with the successful recipients formally announced in June. The program was first launched in 2021 and since that time, NSW Ports has supported over 50 community projects and awarded \$500k in grant funding over three (3) years. One of the successful projects specific to Enfield is supporting an arts program for seniors (older Women's Network Bankstown Wellness Centre) and is in collaboration with other community. NSW Ports recently hosted delegates for the project at the Enfield ILC. This project will involve bringing people into the precinct as part of the arts program (the program will have a transport theme) and it will end with a community event to exhibit participant's art works. It's TBC where this exhibition will be held.
- NSW Ports officially launched its 40-year Master Plan, which has been circulated to members. The plan was formally published in June and is available on the website for download. Members are encouraged to review the document as it outlines objectives, actions, and strategic goals across the next 4 decades.

The modification application is relatively straight forward and ensures the remediation of the site is undertaken in accordance with the previous DA. The Department consent authority will be attending onsite to conduct an inspection. The commencement of construction is likely to be as soon as the DA is approved, noting a conservative timeframe is likely to be 3-4 months, and a best-case estimate being 2 months.

- There has been some recent works on Cosgrove Road (Cnr Hope Street) due to trucks jumping the corner. The modifications are working well, with the exception of a minor incident in the first week due to a truck damaging the guard rail.
- A request for a no stopping sign/s has been received where Bellfrog Avenue meets the access road that runs into the Enfield Goods Yard. The no stopping sign/s have been requested as vehicles come out of the side street. Council noted the request is likely to not be an issue.

HSE Update

8. Summary of complaints/incidents

There has been no environmental complaints and no incidents in the last three months. NSW Ports recently hosted NSW Fire & Rescue on site at Enfield ILC so they could undertake some compliance monitoring of their trucks and to test their equipment.

Louise Symonds highlighted recent noise activity at night with constant beeping (similar to vehicles reversing). While the source of the noise was unknown, it was not thought the noise relates to NSW Ports. NSW Ports indicated they will request night security to monitor and drive around the precinct to listen for noise.

Jon Stewart addressed the group as the new General Manager, Strategy and Corporate Affairs at NSW Ports. He commenced in his position six (6) weeks ago and joined the executive leadership team of NSW Ports reporting to the CEO. He highlighted the importance of senior staff attending the community meetings, and noted regular NSW Ports representatives will continue to attend. He invited the group to provide feedback to Jon directly at any time.
