	<ul><li>They are currently about halfway through this partnership.</li><li>What has been achieved so far:</li></ul>	
	<ul> <li>323 volunteers engaged</li> <li>41KG of litter collected</li> </ul>	
	<ul> <li>6503 seedlings and trees planted</li> <li>9665 m2 of weeds removed</li> </ul>	
	<ul> <li>30 project days delivered</li> </ul>	
	- Thank you to Bayside Council for their support in delivering the project. Providing water to the seedlings to ensure they grow.	
	Questions: MG asked if Bayside Council is taking on the maintenance work after the	
	volunteers have completed their work. TG advised that Bayside would be doing continued maintenance however, this will happen in partnership. Bayside Council will take care of the bigger task such as watering and volunteers will come back and	
	do smaller tasks such as weeding.	
	MG asked about the fire control for the area. To make sure that the fire material/litter material is reduced. How do we make sure that this doesn't become a fire hot spot?	
	JB noted that often offcuts from mowing/weeding are retained to provide protection and habitat for animals. While this might be a fire hazard it provides habitat for the animals.	
	TB noted that typically councils have plans for fire management in these kind of spaces.	
	JB commented on the history of the site. It was underwater years ago. When the ports came in the land was reclaimed and the deal was that the Council had to maintain it however, Council never had the money to maintain it. Council have made some better progress in this space to improve it however, historically the area has been ignored. An artist was	
	commissioned to build the animal sculptures and they have been neglected and need to be fixed.




